



## REG YACHT CODE AUDIT

Azimuth Nautical Solutions is pleased to offer a Red Ensign Group (REG) Yacht Code Audit Service, to assist owners, Masters and yacht management companies in meeting any applicable new Code requirements.

The REG Yacht Code enters into force on **1 January 2019** and has been developed by the UK, its overseas territories and crown dependencies, and international representatives to prescribe standards of safety and pollution prevention which are appropriate to the size and type of yacht.

The new Code consists of two parts: Part A being an update to the existing Large Yacht Code (LY3) and Part B being an update to the Passenger Yacht Code 6<sup>th</sup> Edition (PYC). The Scope of Parts A and B of the new Code have not been changed and are as follows:

- Part A is applicable to yachts which are 24 metres and over in load line length, are in commercial use for sport or pleasure, do not carry cargo and do not carry more than 12 passengers;
- Part B is applicable to pleasure yachts of any size, in private use or engaged in trade, which carry more than 12 but not more than 36 passengers and which do not carry cargo.

In verifying compliance with the REG Yacht Code, our maritime consultants will review the following key areas:

- Quality Management System (e.g. ISM Code)
- Certificates of Survey (e.g. International Tonnage Certificate)
- Area of Operation (e.g. coastal, unlimited etc.)
- Security Systems (e.g. ISPS Code)
- Equipment (e.g. Navigation Equipment, Fire Fighting Equipment, Life Saving Appliances etc.)
- Vessel Stability (e.g. appropriate stability booklet)
- Manning and Qualifications (e.g. Safe Manning Document, MLC Compliance, STCW Convention etc.)
- Specific new survey requirements (e.g. recovery of persons from water, firefighters' communications etc.)
- Status of exemptions and equivalent arrangements

The consultant's observations and recommendations will be reviewed with the vessel's management team before an advisory report is finalised, identifying any non-compliances, observations and opportunities for improvement.
