PORT FACILITY SECURITY OFFICER

This 3-day Port Facility Security Officer (PFSO) course is aimed at those who may be designated to perform the associated duties and responsibilities of a PFSO, as defined in section A/2.1.8 and section A/17.1 of the International Ship and Port Facility Security (ISPS) Code.

It includes maintaining and updating Port Facility Security Plan arrangements and interfacing with Ship Security Officers, Company Security Officers and Government Administrations. The course can be delivered at company premises or another agreed location globally, and upon successful completion of the training course, delegates will receive a PFSO training certificate recognised by the UK Department for Transport.
